



**Medical Scientist, Chief**

**Grade Code 3876**

In exercise of the powers conferred on me by Section 22 of the Health Act 2004, I hereby approve the qualifications, as set out hereunder, for the appointment and continuing as an **Medical Scientist, Chief** in the Health Service Executive.

1. **Statutory Registration, Professional Qualifications, Experience, etc**

<b>(a)</b>	<b>Candidates for appointment must:</b>
<b>(i)</b>	Be registered, or be eligible for registration, on the Medical Scientists Register maintained by the Medical Scientists Registration Board at CORU.
<b>AND</b>	
<b>(ii)</b>	Possess <u>one</u> of the following NFQ Level 9 post graduate qualifications or equivalent qualification at minimum Level 9 validated by the Academy of Clinical Science and Laboratory Medicine;  MSc Clinical Laboratory Science, Dublin Institute of Technology (DIT).  MSc Clinical Laboratory Science, Technological University Dublin (TU Dublin).  MSc Clinical Chemistry, University of Dublin, Trinity College (TCD).  MSc Biomedical Science, University of Ulster (UU)  MSc Biomedical Science, Cork Institute of Technology (CIT)/University College Cork (UCC).  MSc Biomedical Science, Munster Technological University (MTU)/University College Cork (UCC).  MSc Molecular Pathology, Dublin Institute of Technology (DIT)/University of Dublin, Trinity College (TCD).
<b>OR</b>	
<b>(iii)</b>	An equivalent qualification at minimum Level 9 validated by the Academy of Clinical Science and Laboratory Medicine (ACSLM).
<b>OR</b>	
<b>(iv)</b>	Possess Fellowship of the Academy of Clinical Science and Laboratory Medicine awarded before July 2018.
<b>OR</b>	
<b>(v)</b>	Have attained the Fellowship examination of the Institute of Biomedical Science ( <b><i>Awarded prior to 1999</i></b> ).

<b>AND</b>	
<b>(vi)</b>	Possess at least seven years full time clinical experience (or an aggregate of seven years full time clinical experience) as a medical scientist in a clinical diagnostic laboratory since qualifying as a medical scientist, two years of which were spent in a promotional post (e.g. Medical Scientist, Senior or Medical Scientist, Specialist).
<b>AND</b>	
<b>(vii)</b>	Demonstrate evidence of Continuous Professional Development.
<b>AND</b>	
<b>(viii)</b>	Candidates must have the requisite knowledge and ability (including a high standard of suitability, management, leadership and professional ability) for the proper discharge of the duties of the office.
<b>AND</b>	
<b>(ix)</b>	Provide proof of Statutory Registration on the Medical Scientists Register maintained by the Medical Scientists Registration Board at CORU <b><u>before a contract of employment can be issued.</u></b>

**2. Annual registration**

<b>(i)</b>	On appointment practitioners must maintain annual registration on the Medical Scientists Register maintained by the Medical Registration Board at CORU
<b>AND</b>	
<b>(ii)</b>	Practitioners must confirm annual registration with CORU to the HSE by way of the annual Patient Safety Assurance Certificate (PSAC).

**3. Health**

Candidates for and any person holding the office must be fully competent and capable of undertaking the duties attached to the office and be in a state of health such as would indicate a reasonable prospect of ability to render regular and efficient service.

**4. Character**

Candidates for and any person holding the office must be of good character.
