COVID-19 Vaccination Programme Update

Dear Pharmacist,

Thank you for your participation in the Spring Booster Vaccination Programme which concludes on 16th June. The COVID-19 Vaccination Programme will pause over the summer months for the majority of people, with the exception of the cohorts detailed below.

The following groups will be eligible for a COVID-19 vaccination over the summer months:

- Primary courses for those aged 6 months and older.
- First booster dose for people aged 18 years and over (12 years and over if immunocompromised), if it has been at least 4 months since they completed their primary course.
- Pregnant women in the appropriate stage of pregnancy and where the appropriate time since last dose of vaccine has elapsed. Please refer to latest NIAC recommendations for COVID-19 vaccination in pregnancy*.

Community Vaccination Centres

From this week onwards, Community Vaccinations Centres will wind down. Over the summer, vaccination services offered through HSE channels will be limited to the following:

- COVID-19 clinics for children aged 6 months – 11 years.
- Primary course and 1st booster doses to those eligible who are resident in Long Term Residential Facilities, Housebound, in the custody of the Irish Prison Services, and inpatient in a Hospital.
- Provision of non mRNA vaccines to those eligible, with clinics established based on demand.

Summer Vaccination in Community Pharmacies

Community Pharmacists are requested to continue to provide COVID-19 vaccines to the following people if they come forward:

- Those aged 12 years and over who require Primary course vaccination



- Those aged 18 years and over who require a first booster
- Those aged 12-17 years who are Immunocompromised and require a first booster
- Those who are pregnant and require a booster dose

Note that there are still a small number of countries which require foreign visitors to present vaccination certificates, for example Philippines, Indonesia, Iran and Pakistan. In addition, those who are emigrating or studying abroad may require evidence of vaccination.

It is important to ensure that people eligible for a COVID-19 vaccine over the summer months are able to avail of it when requested. Thus we would ask that as many Community Pharmacies as possible make vaccines available to those outlined in the groups above who may present.

Please ensure your details are up to date on the HSE Pharmacy finder through the link below, to ensure information for the public is up to date and accurate www.hse.ie/eng/pharmacy-service-request/.

If you are in a position to continue providing vaccinations over the summer months, please also let us know by sending the name, address and telephone number of your Pharmacy to Vaccinations.PrimaryCareContractors@hse.ie.

This will help us to ensure we have sufficient geographical coverage as well as enabling us to assist individual patients who may contact HSELive requesting assistance to access a vaccination service in their locality.

Patients who require support can contact HSE Live on Freephone 1800 700 700, Monday to Friday, 8am to 8pm, and Saturday and Sunday, 9am to 5pm.

If patients who were eligible for a Spring booster come forward for booster after 16th June, then clinical discretion should be used to assess the risk, benefit and impact on Autumn booster timing before administering a booster. Note that anyone who has received a booster dose since the 1st March has received a Spring booster.

It may be possible to group several eligible people together to maximise vaccine usage. In cases where this is not possible, then one person may be vaccinated from a vial of vaccine to ensure their protection in a timely way.

Autumn campaign

In line with current NIAC guidance, an autumn COVID-19 booster vaccine will be offered to:

- those aged 50 years and older
- those aged 5-49 years with immunocompromise associated with a suboptimal response to vaccination
- those aged 5-49 years with medical conditions associated with a higher risk of COVID-19 hospitalisation, severe disease or death



- health and care workers.

It is planned that the Autumn COVID-19 booster campaign will run in conjunction with the seasonal Flu vaccine, where possible. Further details about the Autumn booster will be released in due course.

Vaccines & Ordering

Vaccine deliveries for COVID-19 vaccines will continue to be fortnightly as per your calendar for June and July, they will then move to monthly until the Autumn, when they will return to fortnightly in the usual way during the Flu vaccine programme period. You will receive a notification when this happens. Please ensure all vaccine orders are placed before your cut off time to minimise the number of exceptional orders that are requested, as these may not always be able to be facilitated.

During the summer period, the vaccine being supplied to Community Pharmacies will be Comirnaty® BA.4-5.

Community Pharmacies should continue to order COVID-19 vaccines through the online NCCS system available at www.ordervaccines.ie.

Please also remember to return any out of date stock of both COVID-19 and Flu vaccine to NCCS using the normal process.

Conclusion

I would like to express my sincere gratitude to Community Pharmacists and their teams for the efficient manner in which the Spring Booster Campaign has been delivered and for your ongoing commitment and support in the provision of COVID-19 Vaccinations.
