Re: HR Circular 020/2021: Health Care Assistants in Mental

Health Facilities

Dear Colleagues,

I refer to the provisions of HR Circular <u>005/2020</u> which outlines the implementation of Job Evaluation for Support Staff resulting in re-banding for certain grades. In particular, Health Care Assistants in specific Mental Health facilities were re-banded to Band 1.

There are Health Care Assistants in Mental Health Facilities who were not part of the sanctioned cohort of listed locations in HR Circular 005/2020. It has come to attention that the difference in pay band potentially causes an inequality regarding recruitment and retention ability for facilities not included in the listed locations. It

has been agreed that effective from 1st January 2021, Health Care Assistants employed in all Mental Health Facilities, will be re-banded to Band 1.

This agreement does not form part of the Job Evaluation sanction. Therefore costs in relation to this will be met from within existing resources in the relevant areas.

For the avoidance of doubt, those Health Care Assistants employed in Mental Health Facilities who, under the terms of HSE HR Circular 005/2020, moved to Band 2 from 1st September 2019 will, as per this circular, move to Band 1 from 1st January 2021.

The Grade Code to be used is 6012 Health Care Assistant Band 1; originally intended for use with the specific mental health agencies, now extended in these circumstances.

The assimilation will be to the next nearest cash point on the higher band, as outlined below.

Please note, new entrant additional increment measures do not apply to Band 1, as clarified in CERS Memo 042/2020.
