Hospitals

Dear Colleagues,

I refer to the agreement of the Department of Health to sanction the regrading of Hospital Managers in Band 3 Acute Hospitals. A list of the hospitals encompassed by the provisions of this circular below:

Letterkenny, Sligo, Mayo, Portiuncula, Tralee, Wexford, Kilkenny, South Tipperary, Portlaoise, Tullamore, Mullingar, Naas, Cavan, Drogheda, JCM Blanchardstown, Navan Hospital.

With effect from September 1st, 2018 relevant hospital managers will be paid in accordance with the salary scale applicable to Head of Function / Service, Community Health Organisations. The salary applicable to this grade as of September 1st 2018 is as follows:

- 1- €90,357
- 2 €94,017
- 2- €97,676
- 3- €101,334
- 4- €104,993

Existing post holders as of that date will progress onto the new scale.

Progression from existing scale will be on the basis of movement to the nearest financial point, not below, on the Head of Service scale.

Please ensure that the contents of this circular are given effect as soon as possible. It should be understood that the funding of this award is to be found within the existing resource allocation of each hospital group.
